



## FREIGHT TRAIN ON CUMBRES PASS

Railfans will get to see a mixed freight train with engines #483 and #484 on the point and caboose 0503 bringing up the rear challenge Cumbres Pass on Sunday, October 22. Jointly sponsored by the NGRRA and Scenic Railways, the train will depart Chama at 8 p.m. and after reaching Cumbres, will be preceded by a regular excursion train to Big Horn and return.

The NGRRA will sponsor a photo caravan from Chama to Cumbres. The Association will sell courtesy tickets of \$5 per carload along the route. The funds will assist in financing this rail special. Photo location maps and souvenir bumper stickers will be given to the shutter-bugs.

Tickets for the passenger train, operating from Cumbres to Big Horn and return, as well as bus transportation to and from Chama and a lunch at Osier are \$25 for adults and \$7 for children. Photo stops will be made between Cumbres and Big Horn for those riding the train.

The format for this years operation is somewhat experimental. If successful the "freight" train run will become an annual event.

In preparation for a mixed freight a few last minute jobs need be done. These include checking car journals, car condition, and assembling the train on Saturday, as well as selling courtesy tickets on Sunday and general publicity of the trip. Details will be announced at the October 16 general meeting, or contact a NGRRA Board Member.

## GENERAL MEETING OCTOBER 16

## BOARD CONSIDERS LOCAL CHAPTERS

The Board of Directors is considering the formation of Local Chapters of the NGRRA. With the increase in membership, there are several geographic areas where members are concentrated, such as Albuquerque, Los Alamos, El Paso, Denver and others. Local Chapters would be allowed to program their own activities, meetings, etc. The Chapter format would provide an organizational structure for communicating NGRRA activities. For many members, a trip to Chama or Antonito is a significant venture. The Local Chapter format may relieve some of the difficulties in travel to and from work projects.

This first photo set includes #497 helping on a tank car train at Windy Point, Rotary OY on a plow turn near Los Pinos and at Phantom Curve, a summer freight upgrade near Cresco, #476 & #478 on a doubleheaded caboose hop in the snow at Antonito and Lava, #483 & #493 on the last mid-train helper operation west out of Antonito, the 1968 National Parks excursion, a tank and flanger train east out of Chama in heavy snow, the San Juan upgrade near Cresco in 1950 the last ever D&RGW train run on December 5, 1968, night shots at Chama, and more. An itemized list is included in the picture set.

## NGRRA ACTIVITIES DURING SUMMER

Activities of NGRRA members during the past summer have included painting and lettering locomotives, riding the C&TS trains as car attendants, preparing rotary OM for display at Cumbres, restoration of mileposts, and reconditioning of the Bunk House at Chama.

The car attendant program has again been a successful addition to the normal activities on the C&TS, as well as providing many NGRRA members their first ride on the Cumbres and Toltec Scenic Railroad. The NGRRA jacket has served as a prominent identifier of volunteers and many passengers have expressed their gratitude in having members enlighten their trip.

Dead engines in Antonito and Chama have been repainted in D&RGW colors and re-lettering for the C&TS is still in progress. Included in the lettering of the engines is a herald prototypal of that used by the D&RGW and designed by NGRRA member Ernie Robart.



Rotary OM is now on display at the Cumbres Pass Depot (old section house). The rotary was rehabilitated with a new roof, windows, and paint, as well as the accompanying water car.

Mileposts along the 64 miles of C&TS trackage have been repainted and numbered. A few mileposts have yet to be replaced.

Of course, during this time there are always those behind the scenes activities which make these and other projects of the NGRRA possible. Everyones participation is appreciated.

## C&TS EQUIPMENT--BOX CARS

Twenty-six box cars were obtained from the D&RGW when the states of Colorado and New Mexico purchased the "Toltec Gorge Route". The cars were built in 1904 and have a nominal capacity of 50,000 pounds. Inside dimensions are: length - 29'5", width - 7', height - 6'1". Car numbers are:
