CREWS BEGIN RESTORING EQUIPMENT

A snow fighting display train for Cumbres Pass is the object of NGRRA restoration crews working in Chama.

During the past weeks, members have been renovating Rotary OM and its tender. Several winters of standing in the Chama yards, lack of maintenance, and vandalism have taken their toll on this former member of the D&RGW snow fighting team. A leaking roof, broken windows, peeling paint, and rotting boards were immediate matters of attention. Although work has been slow due to very small work crews, all that is lacking is a fresh coat of paint and relettering.

The Auxillary Water Car, formerly a metal oil tank car, should be ready for painting after a little scraping.

A K-37 engine will be placed in the snow train display. Other possible items for the consist are a RPO bunk car and flanger. The consist is dependent upon the length of the Cumbres Pass stub track.

The second project of the season will be assembling a freight train for display in the Chama yards.

It is hoped that this train will form a nucleus for an annual freight train to be operated on the C&TS. The project is not formalized at this time; however, Scenic Railways has expressed an interest in such an event.

Although the prime obligation of the NGRRA at this time is serving as car attendants, NGRRA President, Alan Stevens stresses the need for participation in these projects of historical preservation and renovation.

A word about safety -- Safety hats are mandatory when working in the yard and may be obtained at the Chama NGRRA work headquarters. Safety shoes are recommended, as well as safety glasses or goggles. Workers must strictly adhere to all safety rules.
