

For the 93rd year steam powered narrow gauge trains are once again crossing the heights of Cumbres. The C&TS Railroad began daily operations on July 1st. 483 and 484, the workhorses of the line are once again making the regular runs. Contrary to what was reported in the last issue 487 is not yet ready for use. At present it is receiving new flues. 488 should also be running as it too is receiving an overhaul. It is reported that the D&RGW Railroad is readying 481, sister to 483, 484, etc., for use on the narrow gauge Silverton Branch. Once 481, 487 and 488 enter service, there will be five of the ten 480-series engines originally built still in service. Four are out of service, only one having been scrapped. Not a bad record after 48 years of service.

The reservation system is meant to assure that those wanting to work as car attendant, particularly those traveling long distances, be able to do so.

Board sanction was given to the purchase to the purchase and wearing of the NGRRA name tags (available from the Sec't, see May 1973 Telltale for list of items available and costs) for all members not wishing to have their names sewn on work jackets and shirts.

Notification of membership patch is to be sewn on the left side of the jacket above the breast pocket and the name plate or name embroidered in white script 3/4 inch high on the right side. If you have Red Cross Certification, this is to be sewn on the left sleeve below the shoulder seam line.

CHIEF CAR ATTENDANT RULES:

1. Be on time (at least one hour before train time unless riding bus) Chief Car attendant should be on first mode of transportation.
2. Check with Scenic for special instructions.
3. Make sure car attendants have read safety rules.
4. Make sure car attendants know their duties.
5. Assign cars and distribute special instructions.
6. Check out jackets, badges and information books.
7. Give car attendant count to Scenic before train departs.
8. Have all available NGRRA literature and Scenic Railways regular and special schedules.
9. Make sure jackets, badges and information books are returned at conclusion of trip.
10. Make entry in log book including car attendants name, city and state
11. Report complaints, compliments and suggestions to conductor at conclusion of trip (enter in log).
12. Report problems involving safety as soon as possible.
